Course Description

Provides an introduction to the real-world aspects of defending an enterprise network. Students will gain handson experience performing system security tasks and handling incidents. The class begins with a basic introduction to enterprise cybersecurity, the attack sequence, and managing cybersecurity. Then lecture, homework and lab activities cover the center for internet security's essential security controls.

In-Class Recording
