**Course Objectives**

COT5615 covers the basics of vectors and matrices, solving linear equations, least-squares methods, and many applications. It is the prerequisite course for CAP6610 Machine Learning, but the focus will be on using matrix methods in applications such as tomography, image processing, data fitting, time series prediction, finance, and many others.

Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services.
